Report on Payments to Government 2020¹

Anglo American is a leading global mining company with a world class portfolio of mining and processing operations and undeveloped resources. This Report contains payments to Governments made by Anglo American Plc and its subsidiaries ("Anglo American") in the year ended 31 December 2020 as required under both the United Kingdom's Reports on Payments to Governments Regulations 2014 (as amended in December 2015) and Canada's Extractive Sector Transparency Act 2014 (together "the Regulations"). This Report also satisfies the requirements of the Disclosure and Transparency Rules of the Financial Conduct Authority in the United Kingdom.

The Regulations apply to large UK and Canadian incorporated companies that are involved in the exploration, prospection, discovery, development and extraction of oil, natural gas deposits or other materials.

This Report on Payments to Governments complies with said Regulations and reflects the payments made by Anglo American in the scope of its mining exploration and production activity. Payments made in respect of non-mining activity are excluded from this Report as are payments by entities over which Anglo American has joint control or in which it has a minority interest.

This Report, therefore, does not refer to the totality of taxes and payments to governments that Anglo American makes on all of its activities nor does it consider the wider economic contribution Anglo American brings to the countries in which it operates and invests.
