## **Report on Payments to Government 2023<sup>1</sup>**

This Report also satisfies the applicable requirements of the Disclosure Guidance and Transparency Rules of the Financial Conduct Authority in the United Kingdom.

The Regulations apply to large UK and Canadian incorporated companies that are involved in the exploration, prospection, discovery, development and extraction of oil, natural gas deposits or other materials.

This Report on Payments to Governments complies with said Regulations to the extent applicable and reflects the payments made by Anglo American in the scope of its mining exploration and production activity. Payments made in respect of non-mining activity are excluded from this Report as are payments by entities over which Anglo American has joint control or in which it has a minority interest.
